## 1. INTRODUCTION

### 引言

- 1.1. The FXTM June–July 2025 Switch Promotion** (hereinafter referred to as the "Promotion") is available to selected new clients as determined by FXTM. Clients referred by specific media channels, introducing brokers, or affiliate partners are not eligible for this promotion (see Clause 2 for details). By participating in this promotion, you agree to be bound by the following terms and conditions (hereinafter referred to as the "Terms").

富拓2025年6-7月轉戶迎新活動(以下簡稱“活動”)適用於由FXTM富拓決定的特選新客戶(特定媒體客戶及代理商及網絡聯盟商名下的客戶不適用, 詳見條款2)。參加本次活動即表示您同意受以下條款和條件的約束(以下簡稱“條款”)。

- 1.2.** The promotion period starts at 00:01 MT Platform Time on June 16th, 2025, and ends at 23:59 on July 15th, 2025 (hereinafter referred to as the "Promotion Period").

活動期由MT平台時間2025年6月16日0點01分開始至7月15日23點59分止(以下簡稱“活動期”)

- 1.3.** Clients participating in this promotion have the opportunity to receive the "FXTM Switch Reward" in accordance with Clause 4 of the Promotion Terms and other terms and conditions.

參加本次活動的客戶有機會獲得根據本次活動條款4及其他條款和條件所規定的“FXTM轉戶迎新獎賞”。

- 1.4.** This promotion is only available for clients in the Greater China region

本活動僅適用大中華地區新客戶參與。

## 2. ELIGIBILITY CRITERIA

### 資格標準

To participate in this promotion, you must meet the following conditions:

- 2.1.** You are eligible to open an account with the company;

您有資格在本公司開設賬戶;

- 2.2.** You have never made a first deposit with FXTM prior to the start of the promotion;  
您在活動開始前從未在FXTM富拓進行過首次入金;
- 2.3.** You must meet the participation requirements (see Clause 3 for details) to be considered successfully registered;  
您需要滿足參與方式的要求(詳見條款3)方可視為成功報名;
- 2.4.** You currently have an active trading account with another broker and meet the trading requirements with that broker (see Clause 3.4 for details).  
您當前擁有其他交易商的活躍交易賬戶且符合在其他交易商的交易要求(詳見條款3.4)

### **3. WAY OF PARTICIPATION**

#### **參與方式**

- 3.1.** All new clients participating in this promotion must complete the registration and first deposit of their FXTM MyFXTM account by July 15th, 2025, and meet the corresponding trading volume requirements as stipulated in Clause 4 of the Promotion Terms.  
所有參加本次活動的新客戶須於2025年7月15日前完成富拓MyFXTM賬戶的註冊並首次入金, 根據活動條款4的規定滿足相應的交易量要求。
- 3.2.** You are required to provide us with documents that can prove you have an active account with another broker. Such proof may include, but is not limited to, trading history or account statements, screenshots of your client area or trading platform. The supporting documents must contain key information such as your name and the broker's name.  
您需要向我們提供可以證明您在其他交易商有活躍賬戶的文件, 證明文件包括但不限於交易歷史記錄或對賬單、客戶專區或平台截圖, 證明文件需要包括您的姓名及交易商名稱等關鍵信息;
- 3.3.** Your application for the new client switch promotion reward must be submitted via email after meeting the minimum trading volume requirement during the promotion period.  
您的轉戶活動獎勵申請必須於活動期內達到活動最低交易量要求後經由電子郵件申請;
- 3.4.** After the new client has met the initial deposit and corresponding trading volume requirements as specified in Clause 4, you must apply for the reward by sending

an email from the email address registered with FXTM to [promotion@fxtm.com](mailto:promotion@fxtm.com) (hereinafter referred to as the "Promotion Email"). The subject of the email should be "Switch Promotion Reward Application" (hereinafter referred to as the "Email").

- 3.5.** All new clients participating in this promotion will be indicated as accepting of these terms and conditions (hereinafter referred to as "Acceptance").

- 3.6.** Participation Requirements:

- 3.6.1.** This promotion is only available for new clients in Greater China Region (Commitment media clients and clients assigned under IB & Affiliates are not eligible)

- 3.6.2.** During the promotion period, clients may participate in the FXTM Trading Cashback Promotion at the same time, but cannot participate in other FXTM new client promotions simultaneously, unless specifically stated in those promotions.

- 3.7.3** Eligible trades are not applicable to all stocks CFDs and stocks products.

## **4. PROMOTION TERMS**

### **活動獎勵規則**

- 4.1.** New clients will only be eligible to receive the corresponding rewards if all of the following qualification criteria are met:

Minimum Deposit: Eligible clients must make a first deposit of at least USD 200 (or the equivalent amount in the account's base currency) during the promotion

period, in accordance with the platform's minimum initial deposit requirement.

**Minimum Trading Requirements:** Eligible clients must, after making their first deposit, complete the required effective trading volume as specified in the table below during the promotion period, and comply with the relevant trading instrument restrictions.

**Account Switch Trading Volume Requirement:** To apply for the account switch reward, eligible clients must have an active account with another broker and meet the required effective trading lots as specified in the table below.\*

\* Clients are required to provide proof of having achieved the above-mentioned trading

volume with another broker during 2024–2025. Acceptable proof includes trading history or account statements, screenshots of the client area or trading platform, etc. The documents must contain key information such as your name and the broker's name.

Once the new client has met all of the above requirements and sent an email to the promotion email address, we will verify your account eligibility and issue the corresponding reward. The account transfer reward will be credited to your eligible account during the first week of August (2025/08/04–2025/08/08). The promotion reward will not be paid in any other form.

在新客戶同時滿足如上所有要求, 併發送郵件至活動郵箱後, 我們將核對您的賬戶資格及對應發放獎勵, 於八月第一週(2025/08/04-2025/08/08)將轉戶獎勵存入您的合資格賬戶內, 活動獎勵不會以其他形式進行支付。

- 4.2.** A qualifying trade is defined as a complete round trade (opening and closing a position). Only trades where both the opening and closing times exceed 5 minutes will be counted towards the trade volume. Hedging trades will not be counted;

- 4.3.** All new clients can receive the promotion reward only once and cannot participate or receive rewards multiple times;

## 5. MISCELLANEOUS

## 其他事項

- 5.1.** FXTM reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel, or terminate the Promotion. In the event of modifying the Terms, FXTM shall give such notice to the client as be required by applicable legislation. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Promotion.

- 5.2.** Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's Account or multiple account with FXTM or otherwise related or connected to the rewards shall nullify all transactions carried and/or profits or losses garnered therein.

- 5.3.** FXTM reserves the right, at its sole discretion, to disqualify any individual that FXTM suspects misuses or attempts to misuse this promotion, violates these Terms and/or any agreement in force with FXTM by canceling all orders and all profits of such client. FXTM reserves the right to cancel the reward if FXTM suspects any reward grant arbitrage or any abuse or attempted abuse of the Campaign and the Client has opened a position. In these cases, FXTM is not responsible for any consequences resulting from the withdrawal of the rewards.

- 5.4.** Notwithstanding the English language of this document, the Chinese wording shall be the binding version in the event of any discrepancy between the two languages.
